We are seeking a skilled Industrial Maintenance Technician to join our water and wastewater utility team. The ideal candidate will be responsible for maintaining, repairing, and troubleshooting all mechanical and electrical equipment within our wastewater facilities and on the distribution system. This requires knowledge of mechanical processes. This role is essential in ensuring the reliable and efficient operation of our water and wastewater systems

Key Responsibilities:

- Installs, configures, and maintains industrial automation control systems, i.e., PLC's, VF Drives, and HMI
- Installs, repairs, and maintains machinery and mechanical equipment by completing preventive maintenance requirements on pumps, motors, and electrical components.
- Maintains preventative maintenance records.
- Visually inspects and tests machinery and equipment.
- Listens for unusual sounds from machines or equipment to detect malfunction and discusses machine operations variations with team leaders or other maintenance workers to diagnose problems or repair machines.
- Dismantles defective pumps, machines, and equipment and installs new or repaired parts, following approved procedures and specifications.
- Cleans and lubricates shafts, bearings, gears, and other machinery parts.
- Communicates effectively verbally and in writing.
- Ensures work area is kept clean and safe to promote efficiency and safety.
- Complies with established policies, safety standards, and quality procedures to ensure internal and external customer satisfaction.
- Performs additional projects and duties as assigned by the team leader.

Requirements:

- High School Diploma or equivalent.
- Two years of experience in industrial maintenance.
- Industrial automation/maintenance certification is preferred.
- Be an Ideal Team Player (Humble, Hungry, and Smart)
